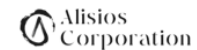

For 5 days, the **1st CPLP Energy and Climate Week** brought together government officials, financiers, entrepreneurs, regulators and energy, environment and finance experts from the nine countries of the Community of Portuguese Speaking Countries in Maputo.

This Week included a set of public and technical events focused on the themes of **Energy Planning, Financing and Regulation**, promoting an institutional and technical exchange, but also stimulating dialogue and the sharing of strategies, good practices, and business opportunities between the different stakeholders.

Taking place after Africa Climate Summit 2 and UN Climate Week, and on the eve of COP30 in Brazil, this Week represented an opportunity to articulate active and collective participation and **project the voice of Portuguese-speaking countries on the international stage.**

5TH CPLP ENERGY AND CLIMATE SEMINAR

20 October 2025

The 5th CPLP Energy and Climate Seminar, on Energy Planning and Financing, continued the CPLP Energy and Climate Seminar Series which, since 2024, has already had editions in [Lisbon](#), [Praia](#), [Rio de Janeiro](#) and [São Tomé](#).

The essence of the Seminar was the official presentation of the **Roadmap for 2030 Cooperation in Energy and Climate in the CPLP Countries**, by the Thematic Commission on Energy and Climate of the CPLP Consultive Observers, whose first strategic pillar is dedicated to energy planning.

In a chained dialogue between the areas of energy, environment and finance, the debate approached:

- Energy planning strategies and policies;
- Incorporating climate adaptation, mitigation and resilience into energy planning;
- Strategies and examples of mobilization of innovative sources of financing and investment.

The [Analysis of Mozambique's Energy Policy](#) by the International Energy Agency was also presented.



2030 COOPERATION ROADMAP IN ENERGY AND CLIMATE IN THE CPLP COUNTRIES

Launched during the 5th CPLP Energy and Climate Seminar, the **2030 Cooperation Roadmap on Energy and Climate in the CPLP Countries** is the first strategic instrument that unites the nine countries in a common vision for a fair, sustainable and inclusive energy transition.

The Roadmap is organized into four strategic pillars: 1. **energy planning**; 2. **capacity building and leadership**; 3. **mobilization of financing**; and 4. **accelerating energy transitions**.

More than a common agenda, the Roadmap is a collective **vision of transformation, progress and development**. The objective is to promote concrete cooperation actions in the CPLP space, but also to promote strategic coordination that strengthens the international presence of Portuguese-speaking countries as a coordinated bloc.

The Roadmap is a dynamic document, designed to **evolve with input from various stakeholders**. During the Seminar, the first partners were announced, and an invitation was made for others to join the initiative.

CPLP ENERGY COLLOQUIUM

21 October 2025

The CPLP Energy Colloquium on Regulatory Paths for the Energy Transition brought a new look at the 2030 Cooperation Roadmap in Energy and Climate in the CPLP Countries, deepening the role of regulation on the various strategic axes identified.

Some of the challenges and opportunities for implementing energy transitions were discussed, highlighting energy efficiency as a pillar of regulation, the role of gas and oil in energy security, and the alternative energies of the future.

The Fact Sheets prepared under the RELOP Energy Transition Working Group and the "National Climate Resilience Assessment of Mozambique" (International Energy Agency) were also presented.

COP30 PREPARATION WORKSHOP

21 October 2025

The Workshop brought together 24 representatives of government entities from Portuguese-speaking countries and international partners to **boost the participation of CPLP countries in COP30**, also seeking to promote coordinated and collaborative action by this regional bloc, ensuring greater representativeness and voice to the common interests of the countries. Several opportunities for joint events have been identified that may take place in the **Portugal and Angola Pavilion**, since both countries have shown this willingness:

1. Presentation of the 2030 Cooperation Roadmap in Energy and Climate in the CPLP countries;
2. Event on the Debt Exchange Mechanism;
3. Presentation of National Climate Finance Strategies/Plans;
4. Event on NDC's alignment strategy with LT-LEDs; and
5. Event on Youth in the CPLP.



XV RELOP ANNUAL CONFERENCE 2025

22 October 2025

The XV RELOP Annual Conference 2025 focused on Regulation for Energy Sustainability and was organized by RELOP, ARENE and INP.

The Conference discussed mechanisms such as the CBAM (Carbon Border Adjustment Mechanism) and the regulatory challenges and decarbonization opportunities they represent for the sector, the role of regulation in attracting sustainable investments, energy security and local value.

Furthermore, **in an unprecedented panel, dedicated to electric mobility, the challenge of preparing a case study of Portuguese-speaking countries on this matter was launched**, taking into account the relevant developments that are seen in each country, welcomed with enthusiasm by all those present, regulators, public and private entities.

TRAINING

IN CLIMATE CHANGE MITIGATION AND ADAPTATION

23 – 28 October 2025

Facilitated by GIZ and GET.transform, in partnership with ALER, under the Long-Term Energy Planning Capacity Building Program for the Mozambican Energy Sector, the technical training focused on **integrating climate change into energy planning**, strengthening national competencies for a resilient, sustainable and climate-aligned energy transition.

The aim was to equip participants with **knowledge and tools to integrate climate projections, greenhouse gas measurements, and resilience assessments into the planning and operation of Mozambique's energy sector**, ensuring that national energy strategies are robust and aligned with the Long-Term Low Emissions Development Strategy (LT-LEDS) and Nationally Determined Contributions (NDCs).

- Presentation of the **2030 Cooperation Roadmap in Energy and Climate in the CPLP Countries**, and announcement of the first strategic partners (GET.transform and AfCEN) and implementing partner (MCA).
- Continuation of the **cycle of dialogue and cooperation** between the Focal Points of Environment, Energy and Finance, with the 5th CPLP Energy and Climate Seminar.
- Organization of the **COP30 Preparation Workshop**, with identification of joint events to be held in the pavilions of Portuguese-speaking countries.
- Launch of a proposal to **develop a case study of electric mobility in CPLP countries**.
- Presentation of **relevant documents**: reports of the International Energy Agency on Mozambique and the Factsheets of the RELOP Energy Transition Working Group.
- Beginning of the **implementation of the pillars of Energy Planning and Capacity Building and Leadership** with the organization of the 5th CPLP Energy and Climate Seminar and the technical training, respectively.

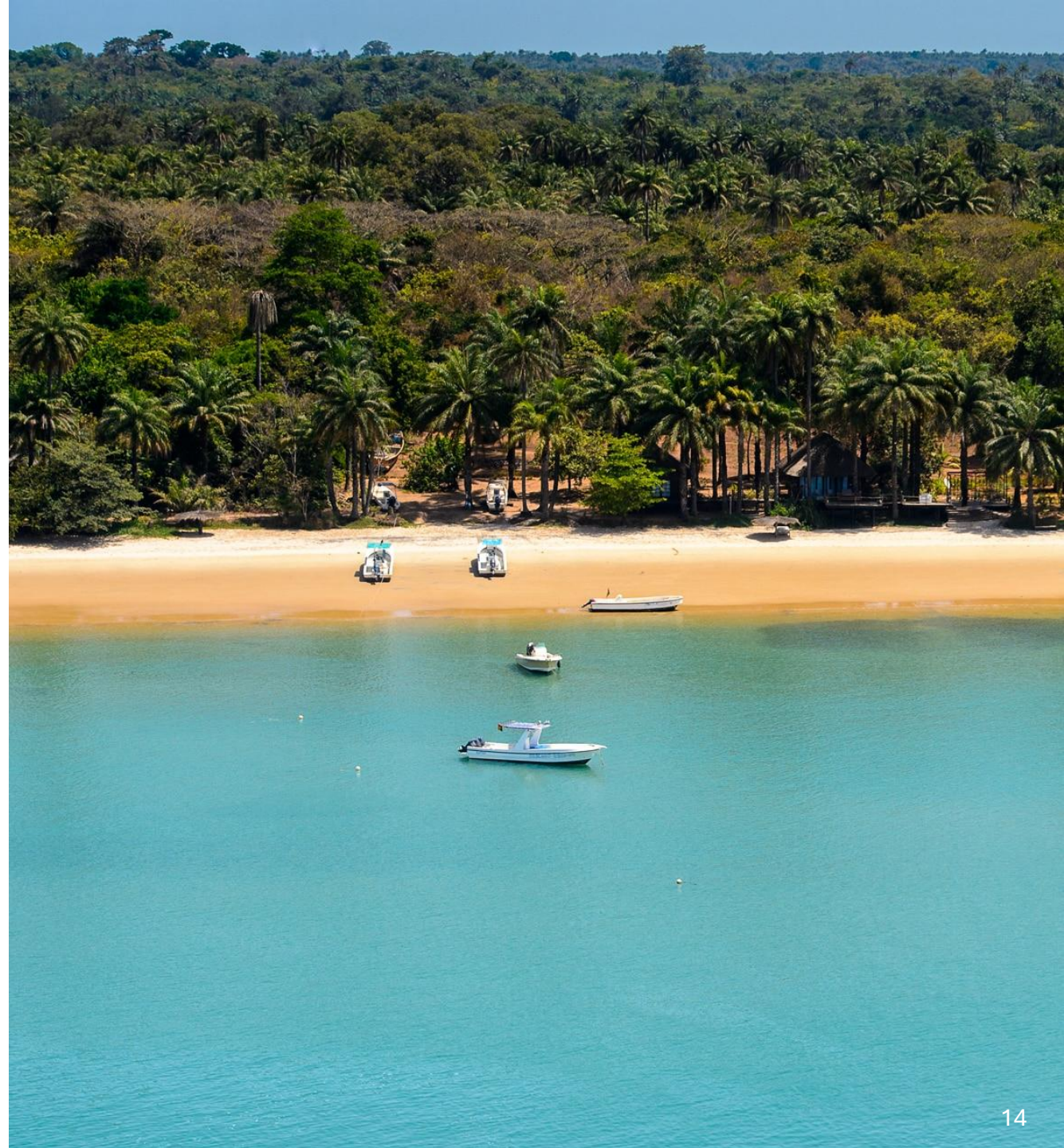
